Call to order:

Current Agenda:

Highlighting Area Providers/Services:

a. ConnectAbility of Minnesota: Sheri Wegner, Executive Director and Amanda Brunotte, Senior Manager-Community Engagement

ConnectAbility is a non-profit organization. They have offices in Duluth, Rochester, and Waite Park but serve all 87 counties in MN. People donate equipment that they have either outgrown or no longer need. ConnectAbility cleans and refurbishes the equipment for others to use. They offer pop-up events at no cost for people to see the equipment that is offered.

They also have an Assistive Technology Lab for people to test before investing in the equipment. ConnectAbility does not sell the equipment but can assist people in obtaining the technology and help them through the waiver process.

They also have inclusive and adaptive events like sensory friendly "Touch A Truck," bowling,

Halloween party, and others. Communities can work with ConnectAbility to learn how to create more inclusive events.

b. Charlie Health: Andrew Warren, Clinical Outreach Manager Charlie Health is an intensive outpatient program connecting the world to life-saving mental health treatment. Charlie Health was founded in Montana in 2019 and have expanded to 38 states nationwide with over 65,000 clients served. In July 2024 they expanded to Minnesota.

They offer solutions to mental health barriers like access to care, waitlists, inflexible schedules, transportation, location outside of clients' safe space, and curriculum not being specialized to marginalized populations. They offer immediate help with virtual intensive outpatient programs. Charlie Health has flexible scheduling Monday through Saturday from morning until evening.

They offer specialized care and individuals participating in support groups will be with others in their same age range and with the same types of trauma/issues. They also offer support groups for parents, guardians, siblings, spouses, etc. of loved ones who are clients. Spanish speaking groups are also available.

They accept Blue Cross/Blue Shield, Medicaid, and other insurances. If someone does not have remote technology, Charlie Health can provide devises, but they are unable to offer connection (WiFi). www.charliehealth.com
